We must work together and remain positive, this has been our strength in the past and as we grow this will be most important to continue to our growth.

8. Reports: Ron Balls Olympic Recognition (Sport Accord / AIMS / IWGA)

Ron Balls gave a background report on what has happened up until now.

- The requirements for the International Olympic Committee (IOC)
- Recognition was given to 2 of 4 applications submitted at the same time as lacrosse, these being International Cheer and Muaythai
- Meeting was held with the IOC in February of 2017 in Lausanne, Switzerland attended by Tom Hayes, Ron Balls and Stan Cockerton
 - FIL delegation was told that FIL had a very good application and were in the top 1/3 of sports being considered.
 - Issue: Oceania and lack of countries from Africa
 - Sustainability of the sport itself
 - Does bid process consider the environment

Ron met with the IOC in April with updated documents taking into consideration:

- Athletes' Commission
- Environment
- Sustainability

FIL documents will be put up for review

FIL is now a part of Alliance of Independent Recognized Members of Sport (AIMS).

FIL became a full member of the International Word Games Association (IWGA).

FIL currently has its application in to acquire provisional recognition from the International Olympic Committee (IOC), and ultimately become a full recognized member.

Questions and Answers

Q: Can the application to the IOC be circulated to the members.

A: Yes

Q: Winter vs. Summer - for lacrosse?

A: Lacrosse is going into the summer stream

Q: Cost to belong to IOC?

A: No cost, Olympic recognised Sports receive funding

Q. If lacrosse becomes a demonstration sport are they a recognised sport?

A: Will be a recognised sport but receive no funding

Q: What is the expectation for number of athletes playing in the game of lacrosse – as per the change to 10 aside in the World Games in Poland?

A: Maximum of 15 athletes per team were allowed by IWGA, so the competition committee felt the game structure of 10 aside for the women's field game was appropriate.

4.4 Residence

Minimum of a two-year residency period in the playing country within the last five (5) years. This does not necessarily have to be a continuous period but a cumulative total period of two (2) years over the previous five (5) years.

For clarity the 5 year time period is that immediately preceding the championship for which eligibility is being sought.

AND

8. Age Limitations

8.1 Lower (Minimum) Age.

The lower limit age that applies to all World Championships and FIL events is 16 years of age as of the day prior to Championship / Event commencement.

8.2 Upper Age for Under 19 Championships

The upper age limit is that all players must be under 19 as at 31st August of the year before the Championships take place.

Reflecting the different start dates of events the Competition Committee may change this date (making it earlier) by up to 10 (ten) weeks and will notify members when Championship dates are confirmed. The 10-week period generally covers the expected time period within which Championships take place.

Any considerations outside of this range will be a matter for the FIL Board, or its successor body, to consider."
