FIL Subscriptions – Limited Review

The subscription levels for members have not substantially changed since the FIL was set up in 2008.

The adjustment that has been made was to set the subscription rate for members moving from Associate Member status to Full Member at \$500.

In 2008 the levels were set by simply adding together the subscriptions paid to the International Lacrosse Federation (ILF) [men] and the International Federation of Women's Lacrosse Associations (IFWLA) and applying a uniform % increase.

This has presented some anomalies particularly where members did not have women's programs in place in 2008 and consequently were not members of and paying a subscription to the IFWLA or were not members of either Federation.

In some instances the membership fee is disproportionate to the number of players within their National Governing Body.

The intent of this limited review has been to adjust for known anomalies and also to apply some rounding where considered appropriate.

The intent has been to correct anomalies rather than seek significant increases and the impact if all proposed increases are agreed, and noting the reductions, is a 1.1% increase in the overall Full Member subscriptions.

Please note that at the General Assembly in 2017 Israel Lacrosse agreed to their subscription level being raised from \$500 to \$1000.

The Board has the authority to and has already agreed the following reductions with effect from 2018:
