C. ATHLETE ELIGIBILITY

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of World Lacrosse, may participate in the LA28 Olympic Games.

Age requirements

C.1. The lower limit age is 16 years of age for men and 15 years of age for women as of the day prior to the start of competition, validated by the passport used for ACR registration.

Additional IF requirements

C.2. Athletes must represent a full or multi-nation member of World Lacrosse in good standing. Full or multi-nation members of World Lacrosse must be part of an IOC-recognised NOC.

This host country NOC quota place will satisfy the minimum allocation requirement of one NOC quota place for the Pan-American Lacrosse Association (PALA CF).</p> <p>If the host country does not participate in the World Lacrosse Sixes Championships, thereby not fulfilling the eligibility requirements for the host country NOC quota, or declines the guaranteed obtained NOC quota place at a later stage, the NOC quota place will be reallocated to the next highest-ranked eligible NOC team from the World Lacrosse Sixes Championships as per section F.2. Qualification for the World Championship* *No Olympic NOC quota is being allocated as it is a qualification pathway for the World Championship	<p>Continental Qualifiers:</p> <p>All full members or multi-nation members of World Lacrosse in good standing have an opportunity to participate in their regional qualifier. Based on final placement in these regional qualifiers, 16 NOC teams qualify for the World Lacrosse Sixes Championship.</p> <p>Note: as Great Britain takes part in the LA28 Olympic Games, only one British nation, Great Britain, will be considered for NOC quota allocation. E. CONFIRMATION

Confirmation of qualification places

E.1. Following the World Lacrosse Sixes Championship, within five days the respective NOCs of the four NOC teams that obtained a qualification NOC quota place will be notified and given 15 days to accept the allocated place.

Following the Qualifying Tournament, within five days the respective NOC that obtained a qualification NOC quota place will be notified and given 15 days to accept the allocated place.

Confirmation of host country places

E.2. Participation of the host country NOC team in the World Lacrosse Sixes Championships is considered an acceptance of the host country guaranteed NOC quota place.

World Lacrosse must confirm in writing to the host country the confirmation of the NOC quota place after the host country participation in the World Lacrosse Sixes Championships and the host country must confirm in writing via email to World Lacrosse at krogers@worldlacrosse.sport the use of its host country NOC quota place.

F. REALLOCATION

Reallocation of unused qualification places

F.1. If a qualified NOC team from the World Lacrosse Sixes Championships declines an obtained NOC quota place, the unused NOC quota place will be reallocated to the next highest ranked eligible NOC team from the World Lacrosse Sixes Championship.

- If the NOC team declining the NOC quota place is the only NOC team from a particular CF, the NOC quota place will be reallocated to the next highest ranked eligible NOC team from that CF, unless the maximum of three qualified NOC teams for that CF has been met, then the reallocation will go to the next highest ranked eligible NOC team from the World Lacrosse Sixes Championships independent of the CF.
- If the NOC team declining the NOC quota is not the only NOC team from a particular CF, the NOC quota place will be reallocated to the next highest ranked eligible NOC team, regardless of the CF, unless the maximum of three qualified NOC teams for that CF has been met, then the reallocation will go to the next highest ranked eligible NOC team from the World Lacrosse Sixes Championships independent of the CF.

If a qualified NOC team from the Final Qualifying Tournament declines the obtained NOC quota place, the place will be reallocated to the next highest eligible ranked NOC team from the Final Qualifying Tournament, unless the maximum of three qualified NOC teams for that CF has been met, then the reallocation will go to the next highest ranked eligible NOC team from the Final Qualifying Tournament independent of the CF.

Reallocation of unused host country places

F.2. If the host country does not participate in the World Lacrosse Sixes Championships, thereby not fulfilling the eligibility requirements for the host country NOC quota, or declines the guaranteed obtained NOC quota place at a later stage, the NOC quota place will be reallocated to the next highest ranked eligible NOC team from the World Lacrosse Sixes Championship, independent of the CF

- If the maximum of three qualified NOC teams for that CF has been met, then the reallocation will go to the next highest ranked eligible NOC team from the World Lacrosse Sixes Championships from the next eligible CF.
